Zone 4 Magazine's official Container Garden Contest Official Rules

NO PURCHASE NECESSARY TO ENTER. Entries for the "Container Contest" will be accepted during the period of June 1, 2010 and ending August 31, 2010. All entries must be received during this time period. The contest is open to legal residents of the United States, who are at least 18 years of age or older. Contest void where prohibited.

GUIDELINES:

1. All container entries must have been designed and grown by the entrant during the 2010 growing season.
2. One entry per person.
3. Entry must include one (1) color digital photo or print.
4. Entry must highlight a single container that contains botanical material.
5. Entry must list botanical material used in the container.
6. Container must wholly surround botanical materials - contest is not open to broken containers used in a landscape feature.
7. All entries must be submitted by August 31, 2010.
8. There is no fee for entering the contest.

SELECTION PROCESS:

All entries will be reviewed by the selection committee. One (1) Grand Prize, one (1) Second Prize and one (1) Third Prize will be selected. Odds of winning depend on the application of the entry guidelines to the entrant's container and total number of eligible entries received. Entry guideline criteria is left to the judgement and discretion of the selection committee and may include: overall aesthetic/appearance, creativity of container selection, creativity of plant selection and arrangement, overall plant health and/or abundance of blooms/foilage and/or uniqueness of entry. Winners will be contacted by email or phone.

ELIGIBILITY:

To enter and be eligible to win or to claim a prize, a person must be a legal resident of the United States who is 18 years of age or older. Contestants may not be an employee of Zone 4 Magazine, its respective affiliated companies or agents, advertising or promotional agencies, companies providing prizes for this contest, or a member of any such employee's immediate family - regardless of where they live - or with persons whom they are domiciled. In these Official Contest Rules, "immediate family" means mother, father, brothers, sisters, sons, daughters or spouse.

GENERAL:

By entering the container contest, entrants agree to abide by the Official Contest Rules and the decisions of the independent contest organization and Sponsors with respect to all aspects of the contest, which are final.

Each selected entrant will also be required to sign a declaration and release form confirming compliance with the Official Contest Rules, acceptance of the prize as awarded, without substitution, and releasing the Sponsors, their affiliated and related companies, advertising and promotional agencies, independent contest organization and their respective shareholders, directors, officers, employees, agents, representatives, successors and assigns from any liability in connection with the prize or this contest. The Declaration and Release Form must be returned within the time period specified on the Declaration and Release Form or the prize will be forfeited. Prizes will be arranged through the Sponsors within 30 days of receipt of the completed Declaration and Release Forms.

2. The Sponsors and the independent contest organization accept no responsibility for loss, damage or claims caused by or resulting from the contest or any prize associated with this contest. By entering and accepting a prize, the winner consents to the use of his/her name, address, city and state, container description, planting guide and/or photograph of their container, without further remuneration, in connection with any publicity carried out by or on behalf of the Sponsors with respect to this contest.

3. The Sponsors and the independent contest organization will not be responsible for late, lost, or damaged Container Contest entries. In the event it is determined that an entrant has entered in a fashion not sanctioned by the Official Contest Rules and/or has submitted duplicate entries, the entrant will be disqualified and all of the entries submitted by the entrant will be disqualified.

All photographs of the winning Container Entries and related intellectual property rights, including but not limited to copyright, become the sole property of the Sponsors, without compensation to entrant. Upon entry each participating contestant irrevocably waives all moral rights protecting the Container Entry. Container photographs may, throughout the contest and thereafter, be distributed, used, exhibited, donated, sold and/or displayed by the Sponsors on their websites or in other forms of media, which rights are granted by an entrant to the Sponsors upon entry, all without notice or compensation to entrant. All winning Container Entry photographs will be displayed on the Zone 4 Magazine website. No correspondence will be entered into except with the selected entrants. This contest is subject to all applicable federal and state laws.
